## MEMBERSHIP CONTRACT – TATTOO CONVENTION

### Art. 1 – Event Dates & Location

Free Art Events is organizing the second edition of the “**Napoli Tattoo Expo**” on **May 30–31 and June 1** in Naples, at the **Mostra d’Oltremare**, Viale J.F. Kennedy 54, 80125, Naples.

#### Event Schedule:

- **Friday, May 30:** Setup from 9:00 to 12:00; doors open at 14:00; close at 01:00
- **Saturday, May 31:** Open 10:30 to 01:00
- **Sunday, June 1:** Open 10:30 to 01:00

Daily closing is 30 minutes after the ticket booth closes.

The organization reserves the right to modify dates, times, and duration without compensating exhibitors.

### Art. 2 – Eligibility

Participants may include:

- Qualified tattoo artists (Italian and international)
  - Body art and wellness professionals
  - Tattoo-related equipment, apparel, and art vendors
  - Public bodies, associations, consortia, and non-profits (for institutional purposes)

## APPLICATION – ACCEPTANCE – WITHDRAWAL

### Art. 3



Equal opportunity is ensured. Only tattoo artists renting a stand for all three days are selected. Counterfeit goods, non-CE certified items, and unhygienic merchandise are prohibited. Applications must be signed and submitted using the appropriate forms.

**Refund Policy:**

If cancellation is communicated **at least two months before** the event, **50% of the paid amount will be refunded.**

**No refund** is given after that deadline.

---

**Event Suspension Not Caused by Organizers**

If the event must be postponed due to weather, environmental, or health issues, a new date **within the same year** will be announced.

If participants cannot attend the new date, **no refund** will be granted.

**STAND INFO**

**Tattoo Artist Booth**

Includes: Panels, 2 chairs, 1 display table, 1 work table, lighting, power strip, special waste disposal, tattoo kit (gloves, mask, paper, disinfectants, plastic wrap, distilled water).

**Not included:** tattoo beds or armrests

**Price:** €550 (VAT included) – **2x2 meters**, single use only

1 tattoo artist + 1 non-working assistant = free access with wristband.

**Vendor & Supplier Booths**

**Indoor (includes VAT)**

- 200x250: €900 (3 passes)
- 400x250: €1700 (5 passes)
- 600x250: €2500 (7 passes)
- 800x250: €3200 (10 passes)

Includes: chairs, desk, panels, lighting, electricity, waste disposal, and social media promotion.

**Outdoor (includes VAT)**

- 200x250: €500 (3 passes)
- 400x250: €800 (4 passes)
- 600x250: €1100 (6 passes)



- 800x250: €1400 (8 passes)

Includes: grass or stone space, power, spotlight, waste disposal, social promotion.

**Note:** No coverage provided. Vendors must supply their own booth setup.

## ENTRY FEES

- **Daily Ticket:**
  - Friday: €13
  - Saturday & Sunday: €15
- **Evening Ticket (from 21:00):**
  - Friday to Sunday: €15
- **3-Day Pass: €35**
- Free entry for children (0–12 years) and people with disabilities

**Prohibited:** Smoking indoors, animals, glass bottles, outside food/beverages.

## ADMISSION TERMS

### Art. 4

By signing the application:

- The participant agrees to all terms (per Italian Civil Code, Art. 1341)
  - Elects domicile at the organizer's address
  - Acknowledges the jurisdiction of the Naples Court

## STAND SETUP & BREAKDOWN

### Art. 5–9 Summary:

- Booths are assigned based on event layout and type
  - Setup: May 29, 17:00–19:00; final setup May 30 morning
  - Booths not set up in time may be reassigned
  - Breakdown: June 1 from 00:30 to 02:00
  - Exhibitors are liable for damages
  - Security and public order services provided
  - Organizers are **not responsible** for unattended belongings

## SAFETY & GUIDELINES

### Art. 10–11

- Setup materials must be flame-retardant or fireproof
  - Booths must have:
    - Washable walls
    - Special waste bins
    - Restrooms and dressing areas
- 

## OPERATOR GUIDELINES

### Art. 12 Highlights:

- Tattooists must have a registered studio, VAT/Tax ID, and health certification
- Only registered tattooists can join contests
- Non-Italian tattooists must comply with local laws
- Strict hygiene protocols enforced:
  - Gloves, masks, disinfectants, single-use tools
  - Signed client consent required
  - Use only certified inks and REACH-compliant materials
  - Minimum tattoo price: **€50**
  - Invoices/receipts must be issued for paid tattoos

Non-compliance will result in **immediate expulsion** with no refund.

---

## TATTOO CONTEST REGULATIONS

- Judges will vote electronically (scored 5–10, including decimals)
- Tie-breaks will be decided by revote
- Categories may include:
  - Micro Tattoo (max 8x8 cm)
  - Black & White (gray not allowed)
  - Realistic (reference photo suggested)
  - Best of Day (must be started and finished on same day)
  - Best Healed (only fully healed tattoos)
  - Best in Show (includes winners from Best of Day and others)

**Important:** Each tattooist may submit **a max of 3 tattoos**. One additional for Best Healed.

If a contestant doesn't appear after two calls, they are disqualified.
